


What is the project about?

Forests are a vital part of Europe's landscape, covering 39% of the EU's territory and playing role significant in the economy, environment, and rural development. The forest-based industry, dominated by SMEs, contributes substantially to the EU's GDP, employing around 3.6 million people across over 400,000 companies. However, the sector faces challenges, including diverse regional policies, modernization needs, sustainability issues. Disparities across regions hinder the full potential of the sector, with some areas lacking the infrastructure or policies to support forest-based industries effectively.









Through stakeholder engagement and tailored interventions, FBI4EU fosters sustainable growth, resource efficiency, and innovation in the forest-based industries. Its impact extends to economic growth in rural areas, job creation, and supporting the European Green Deal's goals for a greener, socially inclusive Europe.



The FBI4EU project aims to address these challenges by uniting eight partners from seven European countries, including business support centers, regional development municipal agencies, authorities, and research institutions. This is focused collaborative effort enhancing competitiveness the and sustainability of forest-based SMEs by developing targeted regional policies, promoting eco-innovation, and sharing best practices across regions. A key player, "Our Land" from Bosnia and Herzegovina, adds valuable regional insights to the project.

Meeting in Poland #1

The Second International Partner Meeting of the FBI4EU project took place in Rzeszów, Poland, from November 26-27, 2024, hosted by the Rzeszow Regional Development Agency (RRDA). Partners from across Europe met to share knowledge, review progress, and discuss future activities. The first day covered the first semester's activities, communication strategies, and financial updates, followed by discussions on GP selection methodology, survey techniques, and a SWOT analysis of the wood sector. REDEA led a session on the forest-based industry's current state, and a key policy workshop focused on unlocking investment opportunities for SMEs in the sector.

On the second day, Onliwood CEO Zbigniew Karaszewski gave a presentation on the innovative timber sales portaul. The second presenter was Stefan Traczyk, President of the Association of Foresters and Forest Owners, presenting the concept of forest chambers, which aims to strengthen the representation of the industry. Following the presentations, participants took part in study tours: the Drek BIK company provided participants with insights into wood processing and innovative forest industry practices; demonstrated advances in sustainable wood processing. The meeting successfully promoted collaboration and innovation among partners.








1st Regional Stakeholder Meeting in Lithuania

The First Regional Meeting of the Stakeholders was held on September 19, 2024 in Lithuania. The meeting was organized by the Lithuanian Research Centre for Agriculture and Forestry, which presented a comprehensive overview of the project and its objectives. The meeting was held through the TEAMS platform and brought together stakeholders drawn from government bodies, forest owners , private companies and academic institutions. The focus was on the challenges facing timber SMEs in light of the European Green Deal and the long-term benefits for companies promoting innovation and sustainability.

Stakeholder Meeting in Bosnia and Herzegovina

The First Regional Stakeholder Meeting in Bosnia and Herzegovina was held on September 27 via Google Meet. The highlight of the meeting was the presentation of the FBI4EU project to the participants, among whom were representatives of institutions from the forestry industry. Participants discussed strategies and policies for innovation and digital transformation, identifying strengths, weaknesses, opportunities, and threats in the sector. The meeting concluded with a discussion on future cooperation to address climate change challenges.







1st Regional Stakeholder Meeting in Croatia

The First Meeting of the Regional Stakeholder Group was held in Međimurje, Croatia, bringing together key stakeholders in the region and forum identify industry providing to opportunities and challenges. Participants were introduced to the FBI4EU project and took an active part in a SWOT analysis of the industry. The meeting focused on sustainability and environmental responsibility, technologies and advances in forestry, and increasing the region's competitiveness. The discussion resulted in the identification of strengths and opportunities, but also highlighted several weaknesses challenges facing the timber sector.

Regional Stakeholder Meeting in Denmark

On November 4, 2024, Norddjurs Municipality held the First Regional Stakeholder Group Meeting of the FBI4EU project in Denmark. Through the meeting, which brought together decision makers and industry leaders, the shaping of the direction of sustainable forestry was examined. The discussion undertaken focused on the direction of forest use in the coming years, the formation of forest policy, and innovation and modernization of the industry. The event highlighted the importance of cooperation in the project and outlined a framework for further action.







Stakeholder Meeting in Podkarpackie Region

On 25 November 2024, the first Regional Stakeholder Meeting of the FBI4EU project took place, hosted by the Rzeszow Regional Development Agency. The meeting was attended by representatives of SMEs from the forestry sector, experts and academic researchers. During the meeting, the main objectives of the project and an analysis of the current situation of the forestry and wood processing industry in the region were presented. Participants actively took part in a workshop, which identified the needs of SME entrepreneurs and the challenges of climate and sustainable development.






Shaping the Future of Forest-Based SMEs


